

1. Any history of metal in the eyes?**a. Yes**

Patient needs an order for an orbit for foreign body x-ray completed with negative result prior to MRI

2. Pacemaker or Defibrillator (ICD)?**a. Yes**

Patient cannot have MRI at Oaklawn, MR Conditional pacemakers may be scanned at outside facilities

3. Heart, carotid, and extremity Stents?**a. Yes**

Proceed but must notify scheduling to make note for MRI safety and proper scanning

4. Abdominal, gastric, biliary, kidney, ureteral, or liver stents?**a. Yes**

Need make and model (or implant card) to schedule

Additional MRI Implant Info:

1. Most orthopedic implants are safe including bone/joint pins, screws, plates, wires, nails
2. Any removable implant or device must be removed prior to MRI (examples: artificial or prosthetic limbs, body piercing, hearing aids, insulin pumps and monitors, medication patches)
3. Dental and tooth implants are safe but may cause an artifact on imaging, if removable patient may be required to remove
